Super Kleral® - liquid treatment for prevention and cure, 15% active concentration level. Triple action formulation combats algae, deposits from scale and metal ions and is a highly efficient clarifier. Dosed manually via buffer tank.

Super Winterprotect - liquid treatment for long term protection, 25% active concentration level. Formulation designed to prevent algae, fungi and scale deposits during winter periods when water is covered and otherwise untreated. Dosed manually into pool.
